- 3. The grant shall be exclusively utilized for the purpose for which it is sanctioned. The money would not be diverted for any other purpose under any circumstance; even for temporary periods
- 4. Assets acquired wholly or partially through grant shall not be disposed-off without obtaining prior approval of UCOST
- 5. The accounts will be audited according to the procedure of the host institution. Audited Utilization Certificate (UC) and Statement of Expenditure (SoE) duly signed by competent authority would be submitted to UCOST after completion of event/financial Year. In case of Private Institutions /Universities, Audited documents must be mandatorily counter signed by Charted Accountant (CA).
- 6. Unspent balance, if any, from the sanctioned grant would be returned to UCOST through bank draft in favor of "The Director General, UCOST" payable at Dehradun as earliest as possible.
- 7. Information about IPR applications received by the IPR cell shall be immediately submitted to UCOST.
- 8. About its forthcoming IPR awareness programmes, one month advance intimation would be sent and IPR experts from UCOST would be invited as guest/invited speakers.
- 9. The account of the programme shall be open to inspection by sanctioning authority/audit whenever the institution is called upon to do so.

These legal rights confer an exclusive right to the inventor/creator or his assignee to fully utilize his invention/creation for a given period of time. It is very well settled that IP play a vital role in the modern economy. It has also been conclusively established that the intellectual labor associated with the innovation should be given due importance so that public good emanates from it. IPR is a strong tool, to protect investments, time, money, effort invested by the inventor/creator of an IP, since it grants the inventor/creator an exclusive right for a certain period of time for use of his invention/creation. Thus IPR, in this way aids the economic development of a country by promoting healthy competition and encouraging industrial development and

• Trade Marks • Patents • Copyright • Registered Design Rights • Unregistered Design Rights; and • Know-how/ Confidential Information

# **Types of Intellectual Properties**

Originally, only patent, trademarks, and industrial designs were protected as 'Industrial Property', but now the term 'Intellectual Property' has a much wider meaning. IPR enhances technology advancement in the following ways.

- 1. It provides a mechanism of handling infringement, piracy, and unauthorized use
- 2. It provides a pool of information to the general public since all forms of IP are published except in case of trade secrets.

This year (2021-22) the workshop was organized in Govt. Degree College Thatyur, Tehri Garhwal on 30/03/2022.


