

In compliance of the University Grants Commission 'UGC' regulation [Furnished under the clause (g) of Sub-section (1) of Section (26) of the University Grants Commission Act-1956] "Draft No. F 1-16/2007 (CPP-II), DATED APRIL 2009" and 'Writ Petition (PIL) No. 23 of 2022' of Honorable High Court, Nainital dated 21st March ,2023, the Government P.G. College, New Tehri, Tehri Garhwal has furnished a ragging prevention document bearing mechanism on curbing the menace of ragging which is as follows:

#### RAGGING AND ITS MENACE Ref. [1, 2, 3 & 4]

As per the UGC regulation on curbing the menace of ragging in Higher Educational Institutions, 2009 ("Draft No. F 1-16/2007 (CPP-II), DATED APRIL 2009") and further as per the guidelines of University Grant Commission (UGC)'s National Ragging Prevention Programme for disseminating the information to the Councils, Universities and the Colleges in India (available at <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>; <a href="https://www.antiragging.in">www.antiragging.in</a> and <a href="https://www.c4yindia.org">www.c4yindia.org</a>), <a href="https://www.agging.in">Ragging</a> is a criminal offense and is a disturbing reality in the higher education system of our country. <a href="https://www.agging.in.cludes">Ragging</a> includes any disorderly act, conduct or practice by which the dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students. It includes individual or collective acts or practices such as:

- Any disorderly conduct, whether by words spoken or written or by an act, has the effect of teasing, treating, or handling with rudeness a fresher or a junior student.
- Indulging in a rowdy or undisciplined activity that causes or is likely to cause annoyance hardship, or psychological harm or to raise fear or apprehension thereof in a fresher or junior student.
- 3. Asking the students to do any act or perform something that such students will not do in the ordinary course and which has the effect of causing or generating a sense

- Any disturbing activity that can lead to adverse effects such as depression, anxiety, and sometimes even suicide.
- 5. Physical assault or threat, and/or use of physical force

- Violate the status, dignity and honour of women students and the students belonging to the scheduled castes and tribes.
- 7. Expose students to ridicule and contempt and affect their self-esteem.

### **PUNISHMENT PROVISIONS**

Any student or group of students found guilty of ragging on campus or off campus shall be liable to one or more of the following punishments:

- Debarring from appearing in any sessional test/ university examination or withholding results
- 2. Suspension from attending classes and academic privileges
- 3. Withdrawing scholarships and other benefits
- 4. Suspension from the college for a period of one month
- 5. Cancellation of admission
- 6. Debarring from representing the institution in any national or international meet, tournament, youth festival, etc
- 7. Suspension/expulsion from the hostel
- 8. Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period
- 9. Dismissal from the institution and consequent debarring from admission to any other institution
- 10. Fine up to twenty-five thousand rupees
- 11. Imprisonment for a term which may extend to two years or with fine which may extend to ten thousand rupees or with both

### ZERO TOLERANCE POLICY IN OUR INSTITUTION

Ragging in any form is strictly prohibited both within the College premises or any other part of the college as well as on public transport. The directives of the University Grants Commission, its Acts, Ordinances and the Guidance of the relevant orders of the Honourable Supreme Court of India (Civil Appeal No. 887 of 2009 dated 8.5.2009) will be strictly adhered to, in all matters related to ragging. Therefore, no act of ragging, major or minor, shall go unnoticed. No ragger, male or female, student or non-student, shall go unpunished.

### CONSTITUTION OF ANTI-RAGGING COMMITTEE AND ITS OBJECTIVES

The Anti-Ragging Committee is constituted every year under the chairmanship of the Head of the institution which acts as a supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus. The main objectives of this Committee are as follows:

- Taking necessary precautionary measures to prevent ragging within and outside the College campus.
- Ensures the implementation of all regulations of the UGC about curbing the menace of ragging in higher educational institutions as per the directives of the honourable Supreme Court of India and UGC.
- 3. Disseminating awareness among the students about dehumanizing effect of ragging.

 Keeping a continuous watch over ragging so as to prevent its occurrence and recurrence.

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". These regulations are mandatory for all universities/institutions.

The Hon'ble Supreme Court, in its judgement dated 08 May 2009 ordered the implementation of a ragging prevention programme comprising, inter alia, setting up a toll-free anti-ragging helpline/ call centre, a database of institutions/ students, and engaging an independent non-government agency as the monitoring agency. Regulatory provisions and the appropriate law are in force to eliminate ragging in all its forms from the universities, deemed universities and other higher educational institutions in the country by prohibiting, preventing its occurrence and punishing those who indulge in ragging.
