### **INSTITUTIONAL PERSPECTIVE PLAN (AY 2022-23)**

The Institution intends to make adequate efforts to impart quality education and achieve its vision, mission, goals and objectives. The Internal Quality Assurance of the college (IQAC) of the colleges has taken adequate initiatives in the preparation of the perspective plan. The perspective plan aims towards the development of the Institution and the all-round development of the students with focus on quality sustenance and quality enrichment. The Institutional Perspective plan for the next five years lays special emphasis on the following areas:

1. The practice of decentralization in governance is to be followed by formation of various Committees including Examination, Admission, Grievance Redressal, Anti-Ragging, Anti-Sexual Harassment, etc and inclusion of teaching and non-teaching staff from various faculties. The formation of Student's Council and the active role played by the student representatives have made the process of governance even more participatory.
2. Each Department must nominate few students to form a Departmental Council and organize various academic activities related to the subject including Debate Competition, Group-Discussions, presentations, etc.
3. The various Departments must make appropriate efforts to inculcate an inter-disciplinary approach towards learning.
4. The Institution will encourage its faculty members to involve in various research activities and academic events and possibilities will be explored in terms of forming linkages with other Institutions.
5. Attempts to be made to make the library more organized and fully automated and enriched with more and better books and journals.
6. Inclusion of ICT tools to facilitate the process of teaching and learning.

7. Community service programs, celebration of commemorative days, awareness camps on social issues to be organized under the NSS wing of the College.
8. Sports and Cultural events to be conducted annually with special themes related to local culture and language.
9. Promote participation of faculty members in national and international conferences/seminars/workshops and symposiums.
10. Provide a platform for the parents of the students enrolled in the Institution to put forward their suggestions and grievances by formation of Parent Teacher's Association.

Apart from the above, some strategic changes were made in the plan based on the exigencies experienced by the Institution during this time period like COVID -19 induced lockdown and the resulting shift to online teaching, adoption of NEP 2020, formation of Intellectual Property Rights Cell, signing of MOU with Department of Fisheries, Govt. of Uttarakhand, etc.

## **DEPLOYMENT DOCUMENTS**

**INTERNAL QUALITY ASSURANCE CELL:** The IQAC has been functional in the college and has been active in implementing the perspective plan mentioned above. The efforts made by IQAC are clearly visible in the IQAC Minutes of the Meeting ([link](#)).

**ADMISSION COMMITTEE:** The Admission Committee is formed annually for all the three faculties: Science, Arts and Commerce. The admissions are being done through fully online mode since the academic session 2018-19 (<https://admission.gpgcnewtehri.com/login.aspx>, <https://admission.gpgcnewtehri.com/prospetus-2022-23.pdf>). As per the GO [No.1197/XXIV-C-4/2021-01(06)/2019 DATED 8<sup>TH</sup> October 2021] of the state government of Uttarakhand, the Institution adopted the New Education Policy 2020 from academic session 2022-23. The admissions have been done in accordance with guidelines (letter ref. no. 3759/ SDSUV/Admin/2022 dated 8<sup>th</sup> august 2022) given by the University with respect to implementation of the NEP in its affiliated colleges. In the session 2022-23, the admissions started in the Institution vide Press Notice Pg No. 664/667/PRAVESH VIGYAPTI /SOOCHNA/2022-23 dated 8<sup>th</sup> August 2022. The Counseling under first merit list for various subjects began on 16<sup>th</sup> August 2022 and the subjects was allotted accordingly. A workshop related to admissions under NEP 2020 was conducted for the students to address their queries related to different issues like choice of major and minor electives, skill enhancement and vocational courses.

The number of seats allotted for graduation courses under the three faculties was as per the letter no. MANYTA/4042, dated 23/-7/2015 of HNBGU and further with reference to the letter Ref No.

SDSUV/co/(228) of SDSUV, Badshahithaul. The vertical and horizontal reservation has been followed as per Letter Ref No. 3759/SDSUV/ADMIN/2022 dated 8.8.2022. Following the above mandate, the number of intake and total number of admissions for various streams under NEP for the academic year 2022-23 were as follows:

The admission to post-graduate courses in the nineteen disciplines were done as per the previous guidelines of the affiliating University which started from 22<sup>nd</sup> October 2022 onwards. As the results of improvement exams were announced the admission dates for the undergraduate courses were further extended to 28<sup>th</sup> April 2023.


**GRIEVANCE REDRESSAL AND INTERNAL COMPLAINTS COMMITTEE:** The Grievance redressal Committee was constituted in accordance with the UGC guidelines for student grievance redressal mechanism IN the college. It comprises the principal as the chairperson, faculty members, non-teaching staff and student representatives nominated by the college. The college has also formed an internal complaints committee as per the UGC regulations 2015 (LINK).

**ANTI-RAGGING COMMITTEE:** The Anti-Ragging Committee was formed in the College as per the UGC Regulation 2009.

**ANTI-SEXUAL HARASSMENT COMMITTEE:** The Anti-Sexual Harassment Committee of the college is formed as per the Vishakha guidelines. It is responsible for not only redressal of grievances related to prevention of sexual harassment in the college but also for spreading awareness and sensitizing the college community about issues related to sexual harassment.

**NSS REPORT:** The NSS wing of the college has played a very crucial role in creating awareness among the students about social and environmental issues and providing them a platform for participation in volunteering for community service activities like tree plantation drives, cleanliness drives, awareness camps, celebration of commemorative days, etc.

**SPORTS AND CULTURAL COMMITTEE:** *The Sports and Cultural activities are organized by the respective Committees annually in the Institution which provides an opportunity for the students belonging to diverse backgrounds to participate and compete in these extra-curricular activities.*
